

## 2022 ADONZ Wage Survey

The 2022 ADONZ Wage Survey was completed by 60 employee DO respondents and 15 students. The low response rate from DOs based in the South Island and students, will have affected the results in those categories.

NOTE: There are currently 197 registered Dispensing Opticians with a current Annual Practising Certificate, and 124 students enrolled in the Australasian College of Optical Dispensing (ACOD) optical dispensing course.

### Background

The ADONZ Annual Wage and Work survey has been undertaken since 2007. The results are used by many Dispensing Opticians, students, and employers (or prospective employers). In 2019 the survey was made considerably shorter, and the questions related primarily to wages to encourage more DOs and students to complete it.

The surveys were available for all employed DOs and enrolled students to complete, with links available publicly on our website and Facebook page. The surveys are completely anonymous and results for DOs are collated into three regional groupings.

To see wage trends, we recommend that this be read in conjunction with results from previous years. Previous years' results are available on the ADONZ website: <u>www.adonz.co.nz/resources</u> Results were not published in 2013 and 2016 due to the very low response rate which would have provided incorrect statistics.

Every care has been taken in the collation of these figures and the survey is as accurate as possible, but compilation errors may have occurred. ADONZ thanks all the DOs and students who took the time to complete this survey - your time is appreciated.

### IMPORTANT: Use of protected title "Dispensing Optician"

#### Dispensing Opticians

At all times a qualified Dispensing Optician whose name is on the register with the Board and is performing any duties within the Scope of Practice (<u>https://gazette.govt.nz/notice/id/2020-gs5669</u>) must hold an Annual Practicing Certificate.

Most Dispensing Optician respondents to this survey noted that they used the title Dispensing Optician. The ADONZ would encourage <u>all</u> registered DOs to use the protected title "Dispensing Optician" along with any management title so that we can continue to educate the public in the role of a Dispensing Optician.

#### Students

The Optometrists and Dispensing Opticians Board requires all students currently enrolled and completing an optical dispensing course to use one of the following titles in the workplace: Trainee Dispensing Optician or Student

**Dispensing Optician rather than Optical Assistant (or any other title).** Other titles can be misleading, and you must ensure that the public is not confused as to your status. You also must not use a title that infers you have more experience that what you have.

#### General

We would remind anyone working in the industry that use of the "Dispensing Optician" title is protected and <u>only</u> <u>registered practitioners are allowed to use thi</u>s. If you are not registered to practice, or if you are studying to become a DO you are not allowed to use this title.

You may not be aware that the term "optical dispenser" should also not be used by persons that are unregistered. Section 7 of the HPCA Act 2003 states: "A person may only use names, words, titles, initials, abbreviations or descriptions stating or implying that the person is a health practitioner of a particular kind if the person is registered, and is qualified to be registered, as a health practitioner of that kind".

The Ministry of Health's view is that the title "optical dispenser" is so like the title "Dispensing Optician" that there is a real risk of consumers being misled. The Ministry's approach in enforcing the Act is to first seek compliance. In cases where the persons are unwilling to comply with the Act, the Ministry will seek to prosecute. Prosecutions under Section 7 carry with them a fine of up to \$10,000. Please make sure that you and the people you work with comply with the Act.

### For your information:

The current minimum wage for an adult in New Zealand is \$21.20 an hour
